DUES PROTECTION opt-out

Dues Protection insurance will be applied if a member is forced or unable to use their membership during the golf season. It covers a partial refund. The Dues Protection covers the following:

- Absence from the region, because of an unexpected change or transfer in employment.
- Illness or physical disability restricting the member from playing golf for the remainder of the season.
- Death.

Dues Protection is an OPTIONAL insurance program available to all members. Dues Protection must be purchased with your membership purchase.

All refunds will be done in cheque form and will be prorated on an individual basis prior to the Insurance Claim.

BLUE FLAG USE FOR POWER CARTS USER AGREEMENT

Kingswood Golf recognizes that individuals using "blue flags" require some relaxation of normal cart use rules to allow them to enjoy their round of golf through improved access, minimizing physical demands and maintaining an appropriate pace of play.

At the same time, "blue flag" users must be aware of the potential damage created by carts and the resulting requirements to additional maintenance. We trust that the following guidelines will allow "blue flag" users to continue to enjoy the game while ensuring that the course maintains the level of quality and safety expected by members and guests.

- Blue flags will be issued to anyone who presents a government issued Disabled Parking Permit.
- During certain times of the year, and/or during certain weather conditions, it may be necessary to restrict all carts, including "blue flag" carts to paths only.
- Except during periods when the course is cart path only, carts may be taken inside the limits of the fairways designated by "no carts" signage. Carts may be taken within the fairway approach up to, but not inside, 12 feet around the putting surface. Carts shall not be driven between greenside bunkers and the putting surface.
- Cart shall remain at least 4 feet off tee boxes and shall not be driven onto any sloped areas around tee box.
- Carts are not permitted in the fescue (tall grass) rough areas of the golf course, as these areas are highly susceptible to damage from cart use.
- It should be understood that the relaxed cart rules are intended to provide assistance to the "blue flag" user only and are not for the use of the passenger. Cart use to and from the passenger's ball shall conform to normal cart etiquette and rules of use.
- "Blue flag" users are advised that any or all of the foregoing rules may be modified as and when required by weather or site conditions. In such cases, the Pro Shop will advise players accordingly.
- Pro Shop staff and on-course marshals will monitor "blue flag" cart use in accordance with the above - noted guidelines.
